

NATIONAL AND INTERNATIONAL REQUEST FOR INFORMATION (RFI) # 06/AMI/EADN/2020

The purpose of the present RFI is to set up a Short-List of potential partners for the Algerian Publicly owned company "EADN" (which translates in English as "Company for the Support of Digital Development"). These partnerships are targeting manufacturers, equipment suppliers, vendors, editors, and systems and solutions integrators.

The call is open to companies covering parts/all of the following areas:

- a) IT equipment and solutions (servers, storage and archiving, networks, appliances, etc.);
- b) Information system security equipment and solutions (data center security, end point protection, firewall, anti-DDoS, SOC, sandboxing, security appliances, etc.);
- c) Complete and integrated platforms and solutions (Converged and/ Hyperconverged infrastructures);
- d) Virtual and physical client workstation equipment and solutions.
- e) Cloud solutions, virtualization and containerisation ;
- f) IT governance and security solutions (GRC, Quality software Management, ITSMIL, IAM, PKI, etc.);
- g) Security testing solutions (pentesting) ;
- h) Monitoring and supervision solutions for IT and network infrastructures;
- i) Middleware solutions ;
- j) Management solutions, ERP, CRM, SCM, etc. ;
- k) Orchestration / Automation Solutions EDM, ECM, BPM, RPA, Knowledge Management...
- l) Solutions for Web portals, e-Service, Smart-Services, CMS, e-learning etc;
- m) E-Commerce, e-Payment, e-Procurement ;
- n) Streaming, VoIP, Web-conferencing, Telepresence, Tele-surveillance & CCTV solutions;
- o) Decision-making solutions, Reporting, Datawarehousing, Dashboarding, BI, Big Data Analytics,
- p) GIS solutions, Web-mapping, Geo-localization, etc.

NB: Candidates can submit to one or more fields.

Eligibility conditions:

For the above-mentioned fields, candidates must have:

- a) The status of equipments manufacturer / Editor or Integrator, and / or partner;

Documents constituting the RFI submission file:

- a) A letter of expression of interest;
- b) A detailed presentation of the company;
- c) Copy of the status of the company;
- d) Copy of the commercial register of the company;
- e) Professional references;
- f) Projects and references by field of activity;
- g) Commercial and technical presence in the region (Algeria, NA/Africa, MENA, MEA/EMEA, etc.);
- h) Proposed partnership programs;
- i) Proposed training and transfer of competence and capacity building curricula;
- j) Any further useful information (e.g. certificate of partnership or certifications for system integrators, etc.).
